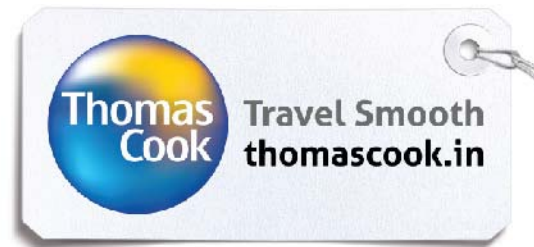

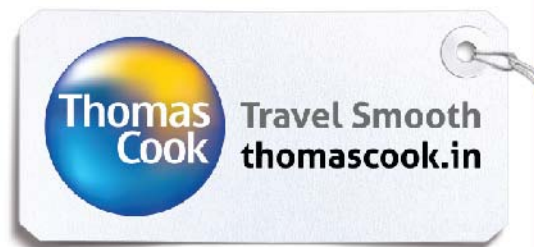

- 3. Best Travel Agency-Indochina** for Thomas Cook India's Destination Management Company **Asian Trails Ltd.**

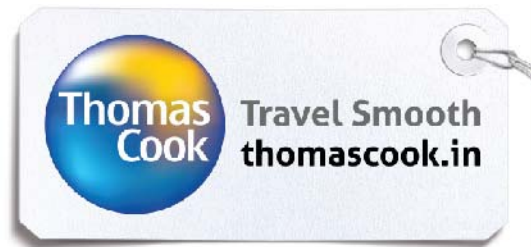
