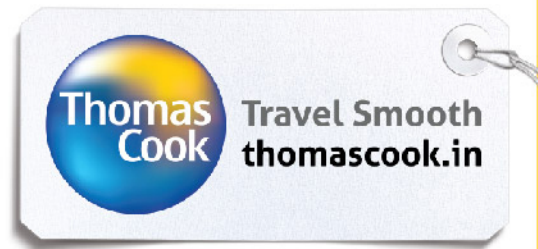

Paris Saint-Germain beats Reims as Mbappe scores twice

The Lionel Messi era has begun at Paris Saint-Germain, without a goal for the Argentine superstar but plenty of adulation and fanfare. Messi made his debut for PSG on Sunday after coming off the bench midway through the second half in a 2-0 win at Reims in the French league. Messi replaced his friend and former Barcelona teammate Neymar in the 60th minute and they shared a hug. After years of glory for Messi at the 99,000-capacity Camp Nou stadium in Barcelona, the record six-time Ballon d'Or winner and four-time Champions League victor made his first PSG appearance at the modest 20,000-seater Stade Auvaise Delaune. PSG coach Mauricio Pochettino was touched by the reception for Messi, pointing out that supporters of both teams were delighted to see him play. "The welcome he got was something beautiful to see and hear, on the part of our fans but also the Reims fans," Pochettino said. "Messi was very happy about it. His presence generates energy, everyone can feel it and it has an effect on the other players."

Before the match, hundreds of fans gathered for a glimpse of Messi as he descended the team bus and he waved back at them. "I wasn't surprised by his enthusiasm," said Pochettino, who did not comment on Mbappe's immediate future. For it remains to be seen whether it's his last for PSG, which has started the season with four straight wins and has 12 points. French champion Lille and Monaco finally won their first games of the season. Changes likely in India's bowling

The Indian playing XI that lost to England by an innings and 76 runs in the third Test at Headingley last week is likely to ring in changes to the bowling attack due to the short turnaround in the last three Test matches. The last three Test matches, including the one that concluded at Headingley are being played inside three weeks and with the Indian Premier League (IPL) and the T20 World Cup coming up over the next two-and-a-half months, the pace bowlers may require some rest. "The rotation is bound to happen. That is a very logical and sensible thing to do. You obviously don't want to push individuals to a place where they break, so that conversation is very important and a very sensible and logical," India skipper Virat Kohli had said after the end of the first

Test. On the basis of Sharmad R Ashwin or Perardul Thakur coming in for off-curling Ishant Sharma looks the most obvious change. Both Ashwin and Thakur could also come in if the team management decides to also rest one of Jasprit Bumrah, Mohammed Shami or Mohammed Siraj besides Ishant. Ishant, although part of Delhi Capitals in IPL, won't be in India's scheme for the T20 World Cup in the United Arab Emirates (UAE) and will, therefore, not have as long a season as Jasprit Bumrah, who will definitely be part of India's T20 squad. Mohammed Shami could also be. Apart from being key to India's T20 World Cup campaign, Bumrah will also be a key bowler for Indians during the remainder of IPL, that begins on September 19. Shami too is Punjab Kings' lead bowler in the IPL.
