Sterling Champions Lifesaving Dialysis Access through CSR Initiative

June 9, 2025 | Chennai, India – Sterling Holiday Resorts, one of India's leading hospitality brands, has deepened its commitment to community health by supporting a transformative dialysis care initiative for underserved regions. The initiative aims to install 2,000 machines across 450 centers in 350 districts to deliver 4.5 million free/subsidized sessions and generate ₹920 crore in patient savings while creating over 4,500 rural jobs.
